1.The group shall be composed of maximum 30 members.2.The members of the group shall be stakeholders' organisations, operating and representing stakeholders at Union level. The organisations shall represent the farming community, other actors in the food supply chain, or the civil society. 3.The organisations shall demonstrate the broadest relevant competence and expertise in areas relevant to agriculture and/or food at Union level and display the widest geographical representativeness across Member States. 4.Each member organisation shall nominate one high-level representative, i.e. holding the position of President, Secretary-General, Director-General or equivalent in their organisation, and shall be responsible for ensuring that their representative provides a high level of expertise.
