Note to the reader

The latest available consolidated trade data at EU level cover market developments in October 2024. Monthly figures can be compared with the previous month. Year-on-year change compares the cumulative trade since the beginning of the year with the same period in the previous year.


The trade figures are expressed in values, except when specifically mentioned. The unit value is the average price of products traded in the period concerned (trade value at the border divided by quantity registered).

HIGHLIGHTS: EU agri-food exports and imports reached record levels in October 2024

EU agri-food trade surplus decreased by 9% in October 2024 compared to the previous month, with a value of EUR 5.5 billion. This is 19% lower than in October 2023, due primarily to higher imports. Cumulative EU surplus until October 2024 reached EUR 56.1 billion (-EUR 1.6 billion compared to the same period in 2023).

EU exports reached the record level of EUR 21.7 billion in October 2024, an increase of 10% on the previous month and 8% higher than in October 2023. This is mainly explained by an increase of export volumes and sustained high export prices since 2022. Since January, cumulative EU exports reached EUR 197.3 billion, 3% higher than during the same period in 2023. EU exports to the US and the UK increased the most, while exports in direction of China and Russia decreased.

EU imports increased by 19% month-on-month in October and also reached a record level at EUR 16.2 billion, 21% higher compared to October 2023. This is explained by increased import volumes, as well as increased import prices, approaching their 2022 level again. Cumulative imports between January and October reached EUR 141.1 billion, 6% higher compared to 2023. Imports from Côte d'Ivoire had the largest increase in value, while those from Australia had the largest reduction.





EU AGRI-FOOD EXPORTS

EU EXPORTS REACHED A RECORD LEVEL IN OCTOBER

EU agri-food exports reached a record high at EUR 21.7 billion in October 2024, a 10% increase on the previous month and 8% higher than in October 2023. This is mainly explained by an increase of export volumes and sustained high export prices since 2022. Cumulative exports since January reached EUR 197.3 billion, a 3% increase on the same period in 2023 (+EUR 5.9 billion).

The **UK** remained the first destination of EU exports, with a value of EUR 44.9 billion between January and October (23% of total EU agri-food exports). This is the destination with the second largest increase in value, with +EUR 1.8 billion (+4%) compared to the same period in 2023, due to increases across a variety of products.

The **US** followed as the second destination of EU exports, with a value of EUR 25.1 billion (13% of EU exports). Main exports to the US are wine and wine-based products, cereal preparations, spirits and liqueurs and olives and olive oil. EU exports to the US had the largest increase compared to 2023 (+EUR 2.5 billion, +11%). This is explained in part by an increase in prices of olives and olive oil exports and increased in volumes and value for a range of other products.

China remained the third destination of EU exports with EUR 11.4 billion (6% of EU exports). However, EU exports to China had the largest reduction, with a decrease of EUR 937 million (-8%) compared to 2023. This is explained in particular by reductions in cereals, pigmeat and dairy products.

CROPS PRICES REMAIN AT A LOWER LEVEL

Exports in the **coffee, tea, cocoa and spices** category had the largest increase in value, with +EUR 2.1 billion (+31%) between January and October compared to the same period in 2023. This was mainly driven by the continuing growth of the prices of cocoa paste, butter and powder, as well as higher export volumes.


EU exports of **olives and olive oil** followed with an increase of EUR 2 billion (+49%) compared to 2023. This is mainly explained by sustained high prices, although they have decreasing in the past months and are approaching their 2023 level again.

Mixed food preparations and ingredients had the third largest increase in value (+EUR 1 billion, +8%), due to both increased volumes and prices.

Exports of **sugar and isoglucose** continue at a high level and have more than doubled in value (+120%, +EUR 666 million), compared to the same period in 2023. Volumes exported have increased by +162%, while prices decreased by 16%.

On the other hand, EU **cereals** exports had the largest reduction in value, with a decrease of EUR 2.1 billion in value (-17%). This is mainly explained by a reduction of prices (-15%), while volumes exported decreased by 3%.

Exports of **vegetable oils** also decreased by EUR 947 million (-30%), due to both reduced prices and volumes (-19%).



EU AGRI-FOOD IMPORTS

EU IMPORTS ALSO AT A RECORD HIGH

The value of EU agri-food imports also reached a record level at EUR 16.2 billion in October. This is a 19% increase on the previous month and 21% higher than in October 2023. This is explained by increased import volumes, as well as increased import prices, approaching their 2022 level again. Cumulative imports since January reached EUR 141.1 billion, 6% higher compared to 2023 (+EUR 7.5 billion).

Brazil remained the first origin of EU imports, with EUR 14.4 billion between January and October (10% of EU imports), largely in soy and coffee. However, they decreased by EUR 388 million compared to 2023 (-3%) mainly due to reduced oilseeds prices and cereals volumes.

UK followed with an import value of EUR 12.7 million (9% of EU imports), mainly in spirits liqueurs, cereal preparations, mixed food preparations and dairy products. Imports from the UK decreased by 2% compared to 2023 (-EUR 203 million).

Ukraine remained the third source of EU imports with a value of EUR 10.9 billion (8% of EU imports), mostly in cereals, oilseeds and vegetable oils. Imports from Ukraine rose by EUR 1.3 billion compared to 2023 (+13%), mainly due to higher vegetable oils and oilseeds imports.

Imports originating from **Côte d'Ivoire** had the largest increase in value between January and

October compared to 2023 (+EUR 2 billion, +60%). This is explained by the continuing increase of cocoa prices. Imports from **Nigeria** also increased significantly, by 153% (+EUR 852 million), as well as those from **Cameroon** (+EUR 564 million, +87%), for the same reason.

On the other hand, imports from **Australia** had the largest reduction in value (-EUR 786 million, -34%), due to a reduction in rapeseed volumes and prices. They were followed by imports from **Russia** that decreased by 43% (-EUR 691 million), due mainly to reduction in the prices and volumes of oilseeds and cereals imports.

COCOA AND COFFEE PRICES KEEP RISING, DRIVING EU IMPORTS

Imports of **coffee, tea, cocoa and spices** continued at a high level, with an increase of EUR 7.1 billion (+41%) compared to 2023, as the price of cocoa products and coffee kept climbing.

Imports of **fruit and nuts** also grew by EUR 1.9 billion (+10%), mainly due to increased prices.

On the other hand, cumulative imports of **cereals** had the largest reduction, with a decrease of EUR 1.8 billion compared to 2023 (-18%). It is primarily explained by reduced prices (-16%), while imported volumes decreased by 3%.

Oilseeds and protein crops decreased by EUR 1.7 billion (-9%). This was overall due to a reduction in prices (-15%), while imported volumes increased by 6%.


